NEW THIS YEAR: We will have an extensive array of flowers available for u-cut. Each 12-week CSA comes with 3 bouquets of u-cut flowers, 6-week members will be able to pick one bouquet. Jars are not provided but will be available for purchase for \$2.

Please choose which day of the week works best for you to pick up your produce. We will do our best to honor your first choice, but each day has a maximum number of slots for pickups. We will email you closer to first pickup date to let you know which day your pickup has been assigned.

Pick up site:

Our first pickup is tentatively scheduled for Monday, June 19, 2016. Our pickup site will be at 13708 Yankee Road Ottawa Lake, MI 49267. The site is the Gust’s second farm and is only a 5 to 10 minute drive northwest of Sylvania, Ohio. Visit our website (listed above) for a map. All produce will be pre-picked for members at the site. Members will bring their CSA bag to mix and match their produce each week from what has been pre-picked. The pickup site will also serve as a small country store and will sell pork, beef, farm raised eggs, etc. Different this year, we will be selling pork and beef in larger quantities, such as ½ and ¼ sections. More information regarding meat sales will be provided closer to the start of the season.

Waiver/Release of Liability

This year, we again will offer you-cut flowers to our CSA members as part of the CSA Program. In doing so, Gust Farms expects that CSA members will venture into fields and will be required to use harvesting tools (for example scissors to cut flowers).

In exchange for participation in Gust Farms CSA in 2017, I agree for myself, family members, and guests, to the following:

I recognize there are inherent risks associated with being a member of the CSA and with being on the Gust Farm Property. I assume full responsibility for personal injury to myself, family members, and guests and further release and discharge Gust Farms CSA for injury, loss or damage arising out of our use of or presence on the facilities of Gust Farms, whether caused by the fault of myself, my family, or other third parties.

I recognize that the produce picked is not pre-washed by Gust Farm’s CSA and that it must be washed prior to consumption. Gust Farm’s is in no way responsible for any CSA Member, family, or guest’s sickness arisen from eating their produce. We do our best to ensure safe food, but it is consumer’s ultimate responsibility to wash and prepare foods safely.

I recognize that there are to be no pets allowed onto the facilities. This is due to the safety of other visitors and Gust Farm’s livestock.

I would like to become a member of Gust Farm’s 2017 CSA Program. As a CSA member, I understand that I share in the bounty as well as the risks that accompany farming. I understand that in the event of a crop failure due to weather, pests, etc., some produce may have to be supplemented from other local growers who have similar growing practices and some produce may not be available at all. I understand that the Produce Growing Chart provided is only a guide and that the actual ripening times of produce may differ. I understand that I have the option to pay all of the money before I receive produce; or half before I receive produce and half by August 1st, 2017. I understand that it is my responsibility to communicate in advance with Gust Farm’s CSA if I wish to change the day I pickup my produce for that week. I understand that Gust Farm’s CSA is not responsible for getting my share to me if I fail to pick it up.
